- The annual shareholders meeting for the year 2021, on 16 April 2021 acknowledged the adjustment amount of IPO money to use in new purpose as the BOD approved a transfer of THB 20 million from Establish Subsidiary in Canada for overseas expansion purpose to working capital with full amount.
