Subject: Report and progress of legal disputes

To: Director and Manager

The Stock Exchange of Thailand

With reference to News Network Corporation Public Company Limited (the "Company") informed the summary of substantial legal disputes on 5 March 2021, the Company hereby would like to inform the progress of such legal disputes in accordance with the Company's financial statements Q1/2022 ended 31 March 2022 as follows:

1. Thansetthakit Multimedia Co., Ltd. has been filed a lawsuit for civil case to the Southern Bangkok Civil Court, Black Case no. Por. 3328/2561, in charge of tort action and publishing information in contrary to the fact against the Plaintiff's principals, agents, employers and employees, and claimed for THB 631 million of damages with the interest rate at 7.5% per annum, including publishing the court judgment in newspapers and website of news station as designated for a period of consecutive 15 days. This case the court set to examine witnesses on 28 November 2022 and negotiation for compromising so that the dispute might be settled. The Company determined not to set the reserve for such debts.

- 2. Thansetthakit Multimedia Co., Ltd. has been filed a lawsuit for civil case to the Southern Bangkok Civil Court, Black Case no. Por. 1349/2563, in charge of publishing information to cause damage against the Plaintiff, which is regarded as tort action, and claimed for THB 51 million of damages with the interest rate at 7.5% per annum. This case the plaintiff's attorney filed a request to withdraw the defendant's lawsuit on 13 June 2022. The court set to examine witnesses on 27 October 2023 and negotiation for compromising so that the dispute might be settled. The Company determined not to set the reserve for such debts.
- 3. Thansetthakit Multimedia Co., Ltd. has been filed a lawsuit to the Southern Bangkok Criminal Court, Black Case no. Aor.1306/2563, in charge of defamation by presenting the news and to seize and destroy 3 newspapers and to advertise all judgments online. This case the court scheduled a preliminary hearing on 27 June 2022, and negotiation for compromising so that the dispute might be settled.
- 4. Thansetthakit Multimedia Co., Ltd. has been filed a lawsuit to the Criminal Court, Black Case no. Aor.2176/2563, in charge of defamation by presenting the news causing damage to the plaintiff's reputation and for the defendants to jointly or interchangeably advertise the judgment in the newspaper and online media and to destroy, delete or remove from the computer system or news that contains defamatory messages. This case the court scheduled a preliminary hearing on 8 August 2022, and negotiation for compromising so that the dispute might be settled.

5. Thansetthakit Multimedia Co., Ltd. has been filed a lawsuit to the Mukdahan Court, Black Case no. Aor.1235/2564, in charge of defamation by presenting the news and claimed for THB 1 million of damages with the interest rate at 7.5% per annum. This case the court scheduled a preliminary hearing on 5 August 2022, including in the process of negotiating the parties and negotiation for compromising so that the dispute might be settled. The Company determined not to set the reserve for such debts.

6. Thansetthakit Multimedia Co., Ltd. has been filed a lawsuit to the Thonburi Criminal Court, Black Case no. Aor.1193/2564, in charge of defamation by presenting the news and claimed for THB 50 million of damages with the interest rate at 7.5% per annum. This case the court scheduled a preliminary hearing on 27 July 2022, including in the process of negotiating the parties and negotiation for compromising so that the dispute might be settled. The Company determined not to set the reserve for such debts.

If there is any important progress, the company will report to investors and the Stock Exchange of Thailand.
