Therefore, it is in order for completion of the allocation of new ordinary shares in accordance with the resolution of the Annual General Meeting of Shareholders of the Company for year 2020, then the Company **considered to extend the periods for subscription and payment of new ordinary shares** from the existing date of 22 – 30 July 2021 (Business days only total 5 business days) during 9.00 am. to 3:30 pm. **to be the date from 22 July 2021 to 13 August 2021 (Business days only total 14 business days) during 9.00 am. to 3:30 pm.**, and the Company hereby changes the details of the payment period and refund period specified on the Notification of the Subscription Rights, Notification of the Allocation, and subscription documents as follows:

1. In case of payment by money transfer

- Payment period for money transfer

Cash transfer Every day, from **22 July 2021 to 13 August 2021 at 3.30 pm.**

Cheque transfer During **22 July 2021 to 9 August 2021** and such cheque must be collected by clearing house in Bangkok within the next business day and such cheque must be **dated no later than 9 August 2021.**

2. In case of payment by Cheque, Cashier Cheque or Draft
 - Payment period for Cheque, Cashier Cheque or Draft

22 July 2021 to 9 August 2021 (Business days only) during 9.00 am. to 3.30 pm. and such cheque must be collected by clearing house in Bangkok within the next business day and such cheque must be dated no later than 9 August 2021.
3. In case of payment by money transfer through BAHTNET
 - Payable during BAHTNET system operating hours of each bank from 22 July 2021 to 13 August 2021 at 3.30 pm.
4. Method of refund of the subscription amount (In case of oversubscription)

The Company shall refund the money (without any interest) to the shareholders via crossed cheque issuance and deliver by registered postal mail to the shareholders at the address as appeared in the share register book on the Record Date of July 7, 2021. The cheque shall be delivered to shareholders within 15 business days from 13 August 2021 (from the end of subscription period).

For shareholders who subscribe after the date of 30 July 2021, are able to use the existing Subscription Form and it is not required to fill in the subscription date on the Subscription Form.

Other than the revisions as abovementioned prescribed, the other details shall be accordance with the Notification of the Subscription Rights, Notification of the Allocation, and subscription documents of new ordinary shares which have already been delivered to the shareholders by postal mail and published on the Company's website (www.ircp.co.th).
